Funding Highlights

During the past fiscal year, the Maury Regional Health Care Foundation funded \$575,237 in programs and services. From assisting with medications for seniors with limited incomes to providing food for those in need, the generosity of our donors has enabled us to impact the lives of others.



Simplifying processes

In April, the Maury Regional Health Care Foundation provided Marshall Medical Center with funding for six new crash carts to help standardize processes for medical staff who

work at both Marshall Medical Center and Maury Regional Medical Center.

Previously, the crash carts were different at the two locations, meaning staff working at both locations had two different sets of protocols to follow. The Foundation provided \$15,789.81 for the crash carts from its General Fund.



In March, the Maury Regional Health Care Foundation provided \$40,000 in grant funding to the Boys & Girls Clubs of South Central Tennessee to support the Clubs' health and wellness programs for local youth.

A portion of the funding went toward training to better equip Club staff to help youth build skills needed to identify their emotions, process them and find healthy coping methods. It included education on different types of mental illnesses, signs and symptoms, crisis management response plans, professional help referrals and more.

The funding included \$30,000 from the Dr. Eslick Daniel Youth Health Initiatives Fund and \$10,000 from the Behavioral Health Fund.



A place for learning

The Maury Regional Health Care Foundation provided funding for a stateof-the-art educational conference room in Maury Regional Medical Group's administrative offices.

The room accommodates up to 40 people and can be used for large group meetings and training sessions. It is equipped with a Cisco virtual room, which includes a Webex Room Navigator tablet. in-ceiling microphones and a Quad Camera SpeakerTrack.

The total cost for the conference room remodel, new furnishings and technology was just under \$65,000 and was provided by the Foundation's General Fund.



Another round of books

Parker Martin and his mother, Sondra Wilson-Martin, visited Maury Regional Medical Center (MRMC) in June to drop off another round of books for families with babies in the neonatal intensive care unit (NICU).

Sondra delivered Parker in November 2016, 10 weeks early. Thanks to the excellent care MRMC's team provided, he is now a healthy and thriving 6-year-old. Following his birth, Parker's parents, both educators, launched Parker's Project, which donates books to the NICU to support other NICU parents and honor his caregivers. Parker's Project has donated more than 1,000 books to the NICU since 2017.

Gifts to support Parker's Project may be made through the Foundation's NICU fund.

Foundation names Medical Staff Giving Circle in honor of Dr. Charles Ball

Dr. Jeffrey Adams first to join

Charles A. Ball, MD, a specialist in family medicine who retired from Maury Regional Medical Group (MRMG) in September of 2020, was a beloved member of the local community as a trusted primary care physician for more than 40 years. The Maury Regional Health Care Foundation recently honored him by establishing the Charles A. Ball, MD, Medical Staff Giving Circle.

A legacy of service

Dr. Ball (pictured right) had a profound impact on not only the thousands of patients he served, but also on the hospital he helped grow into the regional and national leader it is today. He joined the medical staff at Maury Regional Medical Center in 1979 — associated with MRMG from 2002 until his retirement - and during his career was a consistent leader on the medical staff.

During his tenure, Dr. Ball was Maury Regional Health's first chief medical officer and also served as chief of staff, chief of family practice, chief of the medicine department and medical director. He was named the Family Physician of the Year in 2009 by the Tennessee Academy of Family Physicians and was recognized in 1995 as the Rural Physician of the Year by the Rural Health Association of Tennessee. In addition, Dr. Ball held numerous leadership positions in several committees and organizations, including the role of past president of the Tennessee Academy of Family Physicians, the Maury County Medical Society and the Rural Health Association of Tennessee.

"Dr. Ball was a proven leader on our medical staff, and we are grateful for his dedication to our patients and organization over his 40-year career," said Maury Regional Health CEO Martin Chaney, MD. "Naming the Medical Staff Giving Circle in his honor is fitting. Dr. Ball worked tirelessly to improve access to quality health care in our community."

A new way of giving

The Foundation's Medical Staff Giving Circle (MSGC) allows medical staff members to support projects and programs that improve the health of the community, fellow employees and the organization. Members can choose where their gifts are used, whether that be capital projects for the medical center, staff scholarships or for existing Foundation programs and

"The Medical Staff Giving Circle is a great way for our medical staff members to support the work of the Foundation and have a positive impact on our patients and community. It's a true win-win," Foundation Executive Director Joe Kilgore said. To join the MSGC, a cumulative lifetime contribution of \$10,000 required.

members can obtain immediate membership by giving \$10,000 or pledging \$2,500 per year for four years. An annual gift of \$1,000 is required to maintain membership after the \$10,000 level is reached.

Existing medical staff donors will receive a credit for their past gifts toward the \$10,000 level. Those who have met or surpassed the \$10,000 mark automatically become members.

Starting strong

Jeffrey T. Adams, MD (pictured left), a specialist in orthopedic surgery on the medical staff and a Maury Regional Health board member, was the first medical staff member to join the MSGC.

"The Maury Regional Health Care Foundation provides valuable support to our medical staff and organization, which also helps our patients and communities," Dr. Adams said. "It's important that medical staff members reciprocate that support, and I'm happy to join the Medical Staff Giving Circle."



Established Funds

- Medication & Transportation: provides medication, medical supplies and gas cards for patients experiencing financial need
- Palliative Care: assists Maury Regional Health's palliative care program in meeting the unique needs of those facing chronic illnesses in honor of Dr. Maura Lipp
- Service Areas: assists with prescription costs, medical expenses and other needs in the service areas of cancer, cardiology, diabetes, neonatal intensive care, pediatrics and breast health
- The Retreat: operates a hospitality home for cancer patients
- Wayne Medical Center: assists patients and employees of this facility experiencing financial need and funds community health
- William R. Walter Employee Assistance: assists Maury Regional Health employees who have experienced an unexpected crisis or who are pursuing continuing education
